#### Alert regarding fraudulent products possibly present in the Colombian market

In an inspection, surveillance, and control operation, the Instituto Nacional de Vigilancia de Medicamentos y Alimentos (Invima), with support from the Tax and Customs Police (Polfa), confiscated over 4 million units of fraudulent products in Cota (Cundinamarca).

The operation found medicines, dietary supplements, medical devices, food, and phytotherapeutic medicines that violated health standards (e.g. not currently registered with Invima, expired, no marketing authorization numbers on labels, and/or altered labeling or packaging).

The following information shows the products confiscated, grouped according to type of violation:

#### Recommendations

- a. When purchasing over-the-counter products, confirm their composition and valid marketing authorization. Remember that products approved for marketing by Invima must have a marketing authorization number on the label, and this cannot be replaced with words such as "in process" or "authorization pending." The marketing authorization can be consulted <a href="here">here</a>, following the steps explained <a href="here">here</a>.
- b. You can also consult the accuracy of the marketing authorization of products through your Tigo or Movistar cell phone by dialing \*767# for a response via text messaging.
- c. Before using a medicine, phytotherapeutic product, or dietary supplement, review and read the label to identify the Invima registration, the expiration date, and the manufacturer's recommendations on storage.
- d. The information on the labels of drugs, phytotherapeutic products, or dietary supplements should be in Spanish. If the information on the product is in a different language, the product has not been authorized by Invima.
- e. Consider the following when acquiring any product:
  - Only use products approved by Invima.
  - Buy these products in establishments where you can confirm proper storage conditions, so that you can be sure that products you are going to use meet basic standards of quality, safety, and efficacy.
  - When acquiring such a product, confirm that it has a security seal that breaks when the product is opened. Before opening, make sure that the product does not show any signs of deterioration or of alteration in shape or color.
  - Be wary of products advertised on the Internet or other media, offering supposed therapeutic benefits. Unless they are endorsed by the health authority, they may contain undeclared and potentially harmful ingredients.
